

Photo Contest Rules

Please read this document in full before entering the contest.

WHO CAN ENTER

1. To enter, contestants must complete a Photo Submission Form. If under 18 years old, photographer must provide Parent/Guardian Name.
2. Willamalane Park Foundation board members and contest sponsors and the immediate family and other household members (i.e, spouses, parents, grandparents, children, grandchildren, roommates, housemates, significant others, partners, and siblings) of each of the above are NOT eligible to enter and/or win the Contest.

HOW TO ENTER

1. Complete the Entry Fee Form and submit your fee.
2. You will then receive by email a fee receipt with a link to the Photo Submission Form. If you submit your fee and do not receive a receipt with the link to the Photo Submission Form, please contact us at: **WillamalaneParkFoundation@gmail.com**
3. Complete the Photo Submission Form for as many photos as you have submitted a fee. The Photo Submission Form accepts four photos at a time. If you have paid the fee for more than four photos, you must start from the beginning of the Photo Submission Form again.
4. Photos must be taken on Willamalane property. They must fit one of four categories: Dorris Ranch, Nature (Flora and Fauna), Special Events, and Sports and Activities.
5. No mail-in entries will be accepted.
6. Willamalane Park Foundation will contact the photographer in the event that their photo is a winner.

Willamalane Park Foundation shall be the sole arbiters in all matters relating to the contest and in the interpretation of contest rules. Their decisions shall be final. Entry into the contest constitutes agreement by contestants to abide by these rules, as well as any other rules established by Willamalane Park Foundation.

Odds of winning depend on how the contest is conducted. Willamalane Park Foundation has sole discretion to determine how the contest is conducted.

Photo Contest Rules

PHOTO SPECIFICATIONS

1. Each photograph shall be 8.625" width X 11" height with a resolution of at least 300 dpi.
2. Each photo must be labeled with your Name and Category.
3. If all instructions are not completed correctly, you may be disqualified. Your entry fee will not be refunded. Incomplete entries may be disqualified at Willamalane Park Foundation's sole discretion.

ENTRY FEE

Contestants may enter one photo for \$5, OR four (4) photos for \$15. Contestants may enter as often as they wish.

Use of robotic, automatic, programmed or similar entry modes are prohibited and will be void.

Entries that are determined to be fraudulent will be void, and the person making such an entry barred from further participation in the contest.

PRIZES

Prizes will be given for 1st, 2nd and 3rd place winners for each of the four categories. For 1st place, \$75 cash. For 2nd place, \$50 cash. For 3rd place, \$25 cash. One of the four 1st place winners will be the ultimate winner whose photo will be the cover of Willamalane Park and Recreation District's Fall 2019 Park and Recreation Guide.

Prizes must be picked up at Bob Keefer Center for Sports and Recreation OR will be mailed to winner's address. Willamalane Park Foundation will not be responsible for lost, stolen or misdirected prizes once mailed.

IF PICKED UP, Winners are required to present Identification.

Willamalane Park Foundation reserves the right to substitute a prize of equal or greater value for all contests and giveaways. No transfer or assignment of prizes is allowed.

Prizes not claimed within 30 days of being awarded shall be considered forfeited and will become property of Willamalane Park Foundation. Such prize may be disposed of at the discretion of Willamalane Park Foundation.
